List of Changes Made by this Tariff

- (1) <u>New rates</u> the standard hourly rates and extra stop rates listed on page 8 of the previous tariff have been omitted and replaced by a new, increased schedule of standard hourly rates and extra stop rates. These new rates can be found on page 9.
- (2) <u>Deposit</u> all shippers must pay a ten percent (10%) deposit prior to the move. The specifics regarding this deposit are described under the Glossary (see *Deposit*). This new rule can also be found on page 8.
- (3) <u>New hourly minimum</u> the hourly minimum of four (4) hours was listed on page 8 of the previous tariff. The new minimum hourly rate of three (3) hours can be found on page 8 of this tariff.

Glossary

<u>Accessorial Services:</u> Any service performed during the course of the move, other than actual transportation of the goods, e.g., packing, unpacking, appliance servicing. Charges for these services are in addition to transportation costs.

<u>Additional Liability Coverage</u>: A type of coverage offered in replacement of the basic liability coverage of \$0.60 per pound per article as required by the Pennsylvania Public Utility Commission.

<u>Bill of Lading:</u> A formal document required by law noting clearly all services and charges associated with the contracted move of household goods. This is provided within fifteen (15) days of the delivery date.

Breaks: Any stoppage of the move that is in control of the mover, not the shipper, hence also known as a scheduled (tariff) break. E.g. coffee break, lunch break, rest break.

<u>Bulky Goods:</u> Goods of unusual size and low-weight density, often requiring special accessorial servicing, with attending extra charges, e.g. boats, snowmobiles, hot tubs.

Certificate of Insurance: See *Insurance*.

Complaints: A filing that can be made with the PUC if a shipper experiences any problems during or after the move. This must be filed no later than ninety (90) days from the date of the move.

Consignee: The person or entity to which the goods are to be delivered, usually the shipper or the shipper's duly authorized representative.

Consignor: The person or entity which delivers the goods, also referred to as the mover, licensee, carrier or hauler.

Coverage: Coverage refers to the protection offered for loss/damaged goods, and is not to be confused with the mandatory insurance requirements of a licensee. If the shipper sustains a loss or damage to their goods, the shipper is protected up to sixty cents (\$0.60) per pound, per article. If a shipper desires additional

coverage, the shipper may pay a higher tariff rate applicable to the coverage the shipper desires, or obtain a policy of transit insurance with an insurance agent. *See* Additional Insurance Coverage.

<u>Deposit</u>: All shippers are required to pay a deposit of ten percent (10%) of the minimum to be charged for the move. The minimum is calculated as the hourly minimum of 3 hours, multiplied times the hourly rate to be charged, which can be found using the rate chart on page 8.

Estimated cost of services: A formal document required by 52 Pa. Code § 31.122 noting clearly all services to be performed and their respective charges. This is provided at least forty-eight (48) hours prior to the move.

Extra Stop: Any stop for a pickup or delivery of goods, requested by the shipper, in addition to stops at the point of origin and destination of the contracted for move.

Force Majeure: Anything beyond the control of the mover and the shipper which might or actually does impede the contracted for move, e.g. a natural, meteorological, civil, or military disturbance. This includes roadway type or construction.

<u>Flight of Stairs:</u> Inside a building, the number of stairs leading from one complete floor to the next complete floor; outside a building, a set of at least ten stairs.

Fuel Surcharge: A charge specific to the amount of fuel used by the moving vehicle, usually as calculated by the travel time between point of origin and point of destination.

Household Goods: Goods normally considered personal effects and property used in a dwelling when said goods are arranged and paid for by the householder or by another party.

<u>Information for Shippers:</u> A formal document required by 52 Pa. Code § 31.121 which outlines generally the standards of the law under the Commonwealth of Pennsylvania.

Insurance: A type of coverage, the charge and terms of which are determined by the mover, in conjunction with his insurance carrier. The carrier *offers* a particular policy, as the carrier is not licensed to sell insurance, again, in conjunction with his insurance carrier. A *certificate of insurance*, demonstrating that the mover has liability coverage on each vehicle operated by the mover, is required by Pennsylvania law.

Intrastate Move: Shipment of goods point to point within a state.

Inventory: A formal schedule of all goods contracted for shipment required under 52 Pa. Code § 31.133, which should include notations of any pre-existing damage respective to each item. This is provided prior to loading the goods for transportation and then again upon delivery of the goods to the destination. For moves that are 40 miles or less, the inventory requirement may be waived, in writing.

Long Carry: An accessorial service provided when goods are at an extended distance from the actual unloading point of the moving vehicle to the actual destination, as caused by an obstruction beyond the control of the mover, e.g., narrow street, unfinished driveway.

<u>Moving Vehicle:</u> Any vehicle (van or truck, or any version or combination thereof) duly registered with the Pennsylvania Public Utilities Commission, and duly approved and lettered with its assigned license number, used for the intrastate moving of household goods.

N/C: No charge.

N/A: Not applicable.

<u>Origin to Destination:</u> Travel time as determined from the point of the move where the goods are loaded to the point of the move where the goods are unloaded. See *Portal to Portal*.

Overnight Hold: Goods stored on a moving vehicle overnight in lieu of a formal storage facility.

PBO: Goods *packed-by-owner* for moving, and noted as such on all documentation.

<u>Packing/Unpacking:</u> An accessorial service involving the correct and complete packing and unpacking of the shipper's goods by the mover, at the point of origin and point of destination, respectively, including the proper disposal of any materials provided for that service after their use. Clutter will provide packing containers and cartons to the shipper, free of charge. See *PBO*.

<u>Pennsylvania Public Utility Commission (PUC):</u> The governing body that oversees moving companies within the Commonwealth of Pennsylvania.

Point of Origin: Location at which the goods are loaded.

Point of Destination: Location at which the goods are unloaded.

<u>Portal-to-Portal:</u> Travel time as determined from when the moving vehicle leaves its regular base to the point of origin, and when the move is completed, from the point of destination to when the moving vehicle returns to its regular base. This is in addition to travel time from point of origin to point of destination.

Range of Service: Distance the carrier will travel for moves within the Commonwealth of Pennsylvania.

State Authority: Authority for the public moving of all household goods, point to point within any of the sixty-seven counties of the Commonwealth of Pennsylvania.

<u>Transportation Rates:</u> For those moves that are over forty (40) miles, the shipper will be charged at a rate that is determined by the weight and mileage of the move. A chart has been prepared to demonstrate the applicable rate in cents per 100 pounds, which starts on page 5 of this tariff.

<u>Travel Time:</u> The time required by a moving vehicle to proceed from the point of origin to the point of destination. See *Portal-to-Portal*.

Terms & Conditions

Service Area

The Carrier will service all sixty-seven counties in the Commonwealth of Pennsylvania.

Estimated Cost of Services

Carrier will provide an Estimated Cost of Services to the shipper for the move. Estimates will be provided at least forty-eight (48) hours in advance of the scheduled move date, unless the shipper provides written waiver of this notice.

Hourly Moving

The hourly rate begins when the moving vehicle and crew arrive at the point of origin of the contracted for move, and ends when all of the goods have been unloaded at the point of destination, less any scheduled breaks and/or any vehicular breakdown, plus any applicable travel time (see Service Area).

Articles of Extraordinary Value

Articles of extraordinary value, as defined by contract law, including but not limited to, jewelry, special documented antiques of any type, documented artwork of any type, will not be moved.

Articles: Special

No grand or baby grand pianos or large organs of any size or type and other musical instruments. Upright pianos will be moved, but require 3 movers and no stairs.

Articles: Bulky

No utility trailer, pop-up trailer, sail boat, row boat, canoe, skiff, kayak, hot tub, entertainment centers, wall units, grandfather clocks, mechanical furniture that has not been professionally disassembled (including Sleep Number beds), motorized vehicles of any kind, pool tables, large toys or play sets, swing sets, jungle gyms, household or commercial safes.

Articles: Completely Restricted from Moving

The Carrier will not move the following articles: antiques (whether or not breakable and fragile), food or perishable goods (including dried or canned food), liquids (including cosmetics and toiletries), firearms, explosives, used tires, plants, birds, fish, other animals, or any other living thing, arms or ammunition, any item which emits fumes, smells or odors, bullion (e.g., gold-silver), jewelry, currency, ivory, precious metals or stones, any

drugs, illegal substances or goods, or goods or substances illegally obtained, human remains, combustible or flammable materials, liquids or compressed gases, diesel, petrol, oil, gas, artificial fertilizer or cleaning solvents, chemicals, radioactive materials or biological agents, toxic waste, asbestos or other materials of a dangerous or harmful nature, any other toxic, flammable or hazardous goods, or any other items, the possession or usage of which may violate in any way the laws of the United States or any other applicable laws, rules, or regulations (collectively, "Prohibited Items").

Impractical Operations

The mover is not liable for the execution of a move when any of the following impede or otherwise make impractical the same: acts of God, including any natural, geological, or meteorological occurrence or disaster; any acts of war, declared or undeclared; any civil disturbances, including, insurrection, rebellion, riot; any labor dispute, strike or lockout; any act of the state or federal government regarding nationalization, sanction, embargo, or blockade; any act of foreign invasion or hostilities; any act of terrorism; any interruption of a public utility or Internet service; severely inclement weather; any inadequate or unsafe road, highway, street, or driveway conditions, or major construction or repair of the same or any major delays or detours arising therefrom; any situations where hazardous materials are present; any major access obstructions at either the origin or destination; as well as any situations where the moving crew is or might be personally endangered or threatened with physical harm.

Infestation / Fumigation

With respect to any household goods transported by the carrier, which are, or have been reasonably demonstrated to be, infested with ants, termites, cockroaches, bed bugs, or any dangerous or disease bearing insect, as a result of the condition of the shipper's premises, at either origin or destination, the carrier reserves the right to refuse shipment of such goods, (a) entirely or (b) after they have been duly certified by a fumigation specialist to be free of the manifest or discreet infestation.

With respect to any household goods transported by the carrier, infested with ants, termites, cockroaches, bed bugs, or any dangerous or disease bearing insect, as a result of the condition of the shipper's premises, at either origin or destination, and the same having infested the moving vehicle as a result of the move, all costs resulting from any fumigation, or other acts or procedures necessary to return the moving vehicle to a sanitary state, will be charged back to the shipper.

Assembly / Disassembly

The carrier will not be responsible for disconnecting, reconnecting, dismantling or reassembling appliances, fixtures, fittings or equipment. Carrier will not remove any items screwed, nailed or bolted into walls and/or ceilings, attached to windows, or remove any wiring from other electronics, appliances, walls and/or hardwired into walls.

The shipper can elect to have the carrier to dismantle or assemble any unit, system, or furniture at a rate of \$150.00 for each piece, plus standard hourly rate.

Packing / Unpacking

Packing and unpacking services are available at the standard hourly rate. Clutter will provide packing containers and cartons to the shipper, free of charge.

Disposal of Unwanted Goods

The carrier will not dispose of unwanted goods from the shipper's inventory without prior written authorization accompanied by an itemized list. The carrier will charge a minimum fee of \$50.00 for each item, plus the standard hourly rate.

Appliance Servicing / Electrical and Mechanical

The Carrier will not be responsible for appliance, electrical and/or mechanical servicing but will coordinate with shipper to pick up and/or deliver inventoried items within service area and proper authorization billed at the standard hourly rate.

Rigging

The carrier will not be responsible for rigging of inventory items.

Long Carry

The carrier will charge for a long carry at the standard hourly rate.

Stair Carry

The carrier will charge for stair carry at the standard hourly rate.

Elevator Access and Reservation

The carrier will not be responsible for any reservation for elevator access in a building or setting at either the origin or the destination of the move.

Toll Charges

Toll charges for any bridge, tunnel, ferry, or highway, incurred by the mover, between the origin and destination of the move, will be charged back to the shipper.

Governing References

The computation of mileage between the origin and destination of a move will be determined by googlemaps.com

The computation of weight and market depreciation of a given household and/or commercial good will be determined by the Joint Military / Industry Table of Weights and Depreciation Guide, AMSA Publication, April 2000 edition.

Break Policy

The Carrier's employees on a contracted for move job are required by carrier's policy to take a 30-minute unpaid lunch break by their 5th hour of work.

Disposal Fee

\$50.00 minimum per item + Standard Hourly Rate

Additional Liability Coverage

The shipper may elect for additional liability coverage for their goods at a rate of \$50 per \$100 declared under Section 2(b) of the Estimated Cost of Services. In order to be eligible for this additional liability coverage, the shipper must declare the value of their goods to be at least \$100. If elected by the shipper, this coverage would be offered as a replacement to the basic liability coverage of \$0.60 per pound per article.
