

The following container, packing, & unpacking rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less and distances in excess of forty (40) miles.

PACKING AND UNPACKING: Rates for packing include packing labor and materials; rates for packing and unpacking include packing labor, the use of packing containers and materials from origin to destination, and unpacking labor.
