100	To transport, as a common carrier, by motor vehicle, persons in limousine service, between points in Pennsylvania, excluding service that is under the jurisdiction of the Philadelphia Parking Authority.

200	<p data-bbox="722 394 1128 426" style="text-align: center;"><u>ADVANCED RESERVATIONS</u></p> <p data-bbox="435 464 1365 531">Reservations must be made at least one (1) hour in advance of the scheduled pick-up time.</p>
210	<p data-bbox="625 594 1221 625" style="text-align: center;"><u>PAYMENT OF OUT-OF-POCKET EXPENSES</u></p> <p data-bbox="435 663 1406 835">All highway, bridge and other tolls, entrance and parking fees, and other similar out-of-pocket expenses shall be the responsibility of the customer and shall be added as an additional charge. On out of town trips which are in excess of ten (10) hours in length, there will be an additional charge for the driver's lodging and meal expenses.</p>
220	<p data-bbox="753 896 1089 928" style="text-align: center;"><u>OVERNIGHT EXPENSES</u></p> <p data-bbox="435 966 1398 1171">When, upon the request of the customer, an overnight stop is made en route, or at the destination, the actual expenses of the driver for the evening meal, overnight lodging and breakfast shall be paid by the customer, in addition to all other charges. The driver shall have at least eight (8) hours off-duty time which will not be considered in calculating the hourly charges for service. All other time is considered live time for purposes of calculating the Carrier's charges.</p>
230	<p data-bbox="708 1199 1125 1230" style="text-align: center;"><u>COMPUTATION OF CHARGES</u></p> <p data-bbox="428 1268 1386 1335">Hourly rates will apply from the time the vehicle picks up the first passenger at origin until the vehicle drops off the last passenger.</p>
240	<p data-bbox="792 1400 1040 1432" style="text-align: center;"><u>HOLIDAY RATES</u></p> <p data-bbox="428 1470 1370 1570">There will be an additional charge of twenty (20%) percent of the hourly rates for service provided during the following holidays: New Year's Eve, New Year's Day, Christmas Eve, Christmas Day and Thanksgiving.</p>

250	<p data-bbox="756 432 1078 464" style="text-align: center;"><u>PROMOTIONAL FARES</u></p> <p data-bbox="428 506 1382 747">Upon presentation of an advertising coupon or special promotional offer, Carrier will offer rates at a specified discount from the published tariff rate on dates authorized by the coupon or special offer. The advertised coupon or special offer will be filed with the Pennsylvania Public Utility Commission prior to publication or broadcast. Coupons will be published and promotional offers will be presented in one or all of the following media: local newspaper, fliers, radio, television and internet.</p>
260	<p data-bbox="630 842 1203 873" style="text-align: center;"><u>DEPOSITS AND CANCELLATION POLICY</u></p> <p data-bbox="428 915 1390 1230">Carrier may, as a condition of accepting a reservation for a limousine vehicle, require a deposit of not more than twenty (20%) percent of the quoted charges for the trip. If the reservation is cancelled by the customer more than fifteen (15) days, but less than thirty (30) days, prior to the date that the transportation service was to be provided, fifty (50%) percent of the deposit shall be forfeited, with the balance returned to the customer. If the cancellation of the trip occurs within fifteen (15) days prior to the date that the transportation service was to be provided, one hundred (100%) percent of the deposit is subject to being forfeited.</p>

270	<p data-bbox="753 432 1101 464" style="text-align: center;"><u>VEHICLE DESCRIPTIONS</u></p> <p data-bbox="440 506 1377 604">Service shall be provided in a luxury sedan with a seating capacity of five (5) passengers (including the driver), such as a Lincoln Town Car, Cadillac DeVille or similar luxury vehicle.</p> <p data-bbox="440 646 1393 711">Service shall also be available in a luxury Sports Utility Vehicle (“SUV”) with a seating capacity of eight (8) or fewer passengers (including the driver).</p>
