AMENDMENT TO VALLEY FORGE
SEWER TREATMENT PLANT AGREEMENT

THIS AMENDMENT, dated as of January 1, 1983, to the Valley Forge Sewer Treatment Plant Agreement dated as of November 1, 1970, is entered into between the parties to said Agreement, namely, Valley Forge Sewer Authority, the Townships of Schuylkill, East Pikeland, Charlestown, East Whiteland, Tredyffrin, Willistown and Easttown, the Borough of Malvern, Malvern Municipal Authority, East Whiteland Municipal Authority, Easttown Municipal Authority, Tredyffrin Township Municipal Authority and Willistown Township Municipal Authority.

Said Agreement, as it has previously been amended, is hereby further amended to provide that commencing January 1, 1983, all amounts not paid by any municipality or municipal authority when due shall be subject to interest at a rate equal to the prime rate charged for the loan of money by Continental Bank, or its successors, as the same may be adjusted by said Bank, or its successors, from time to time. If Continental Bank and its successors cease to exist, the Joint Board shall select another bank and its successors, which upon selection by the Joint Board shall be automatically substituted for Continental Bank and its successors.

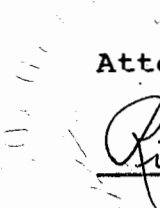
The intent of this Amendment, commencing January 1, 1983, is merely to substitute a flexible rate as above provided wherever

said Agreement provides for a fixed rate of six percent per annum.
This Amendment shall be so construed.
