The service territory map encompasses the municipal boundaries of The City of York. In addition, the service territory encompasses three parcels where the wastewater treatment plant is in Manchester Township (see **Appendix A-16-c**, page 6 of 6 for bearings and distances).

North York Borough Bulk Interconnection. The interconnection receives bulk sewage from North York Borough through a metered single sewer collection line at a manhole location within Manchester Township approximately 400 feet east of Toronita Street and approximately 300 feet north of the North York Borough and Manchester Township municipal boundary lines.

Manchester Township Bulk Interconnection (1 of 3). The interconnection receives bulk sewage from a portion of Manchester Township through a metered single sewer collection line at a manhole location within Manchester Township approximately 400 feet east of Toronita Street and approximately 300 feet north of the North York Borough and Manchester Township municipal boundary lines.

York Township Bulk Interconnection. The interconnection receives bulk sewage from York Township through a metered single sewer collection line at a manhole located within Spring Garden Township on the York College property approximately 500 feet west of S. George Street (The City of York and Spring Garden Township municipal line) and 450 north of Country Club Road in Spring Garden Township.

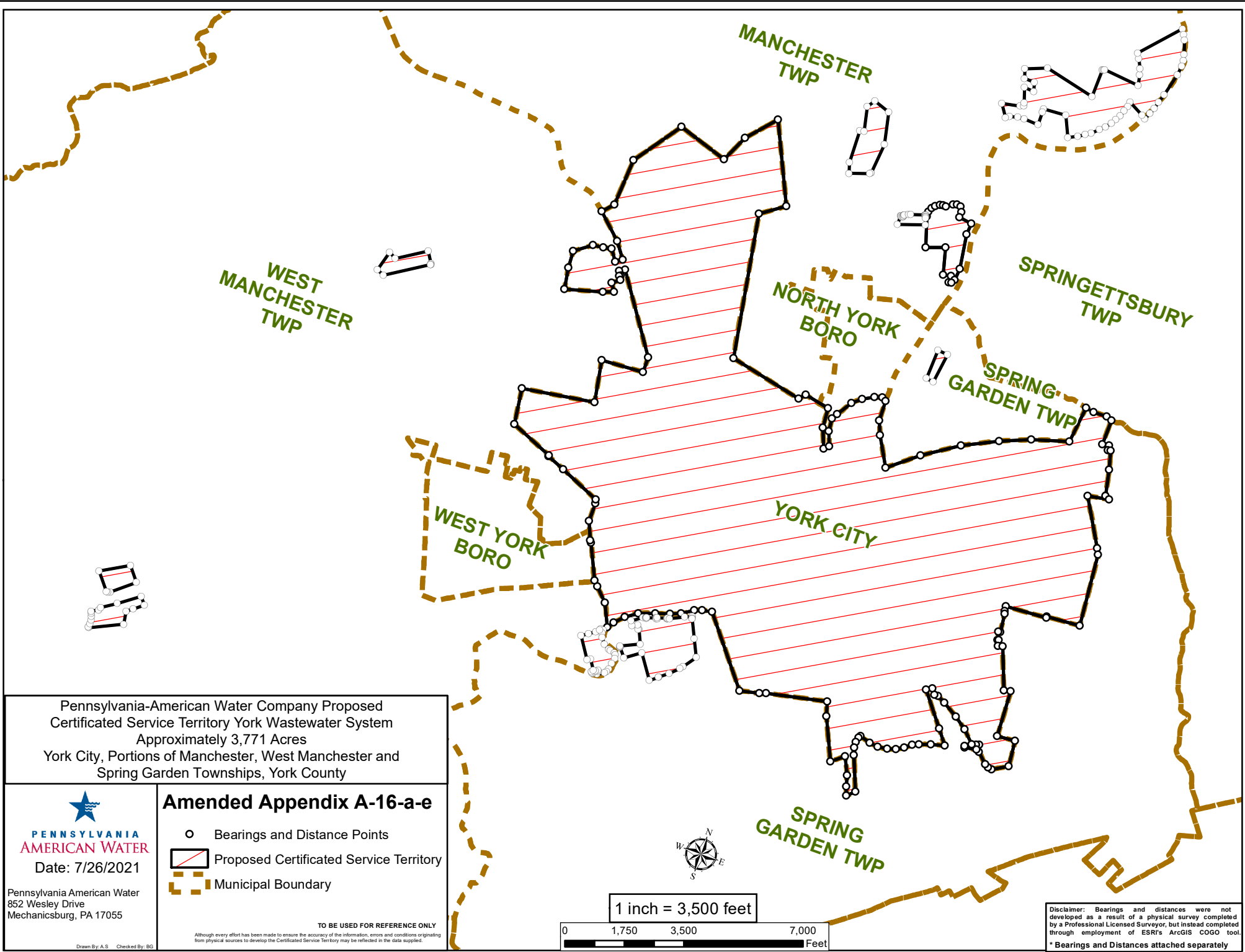

West York Borough Bulk Interconnection. The interconnection receives bulk sewage from West York Borough through a metered single sewer collection line at a manhole located in West Poplar Street approximately 180 west of Rusk Avenue at The City of York and West York Borough municipal line.

West Manchester Township Bulk Interconnection (1 of 2). The interconnection receives bulk sewage from a portion of West Manchester Township through a metered single sewer collection line at a manhole located approximately 300 feet west of the intersection of Roosevelt Avenue and Wood Street at The City of York and West Manchester municipal line.

West Manchester Township Bulk Interconnection (2 of 2). The interconnection receives bulk sewage from a portion of West Manchester Township through a metered single sewer collection line at a manhole located within South Richland Avenue approximately 50 south of Codorus Street within the City of York.
