

NOTE 2 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

◆ NOTE 3 - A charge of \$25.00 per man per hour for the second helper or more.

NOTE AA - A flat charge based on one-half (1/2) hour when distance from original point of origin to final destination is 10 miles or less.
