▲ ♦ NOTE 6 - If a refrigerator or safe are included in the shipment, a handling fee of \$100.00 per item will apply in addition to the applicable hourly charges. A special handling fee of \$100.00 will apply for Grandfather Clocks, Arcade and Pinball machines, and Peloton or similar exercise equipment in addition to the applicable hourly charges. The handling fee when a piano is included in the shipment will be a \$100.00 fee in addition to the applicable hourly charges.
