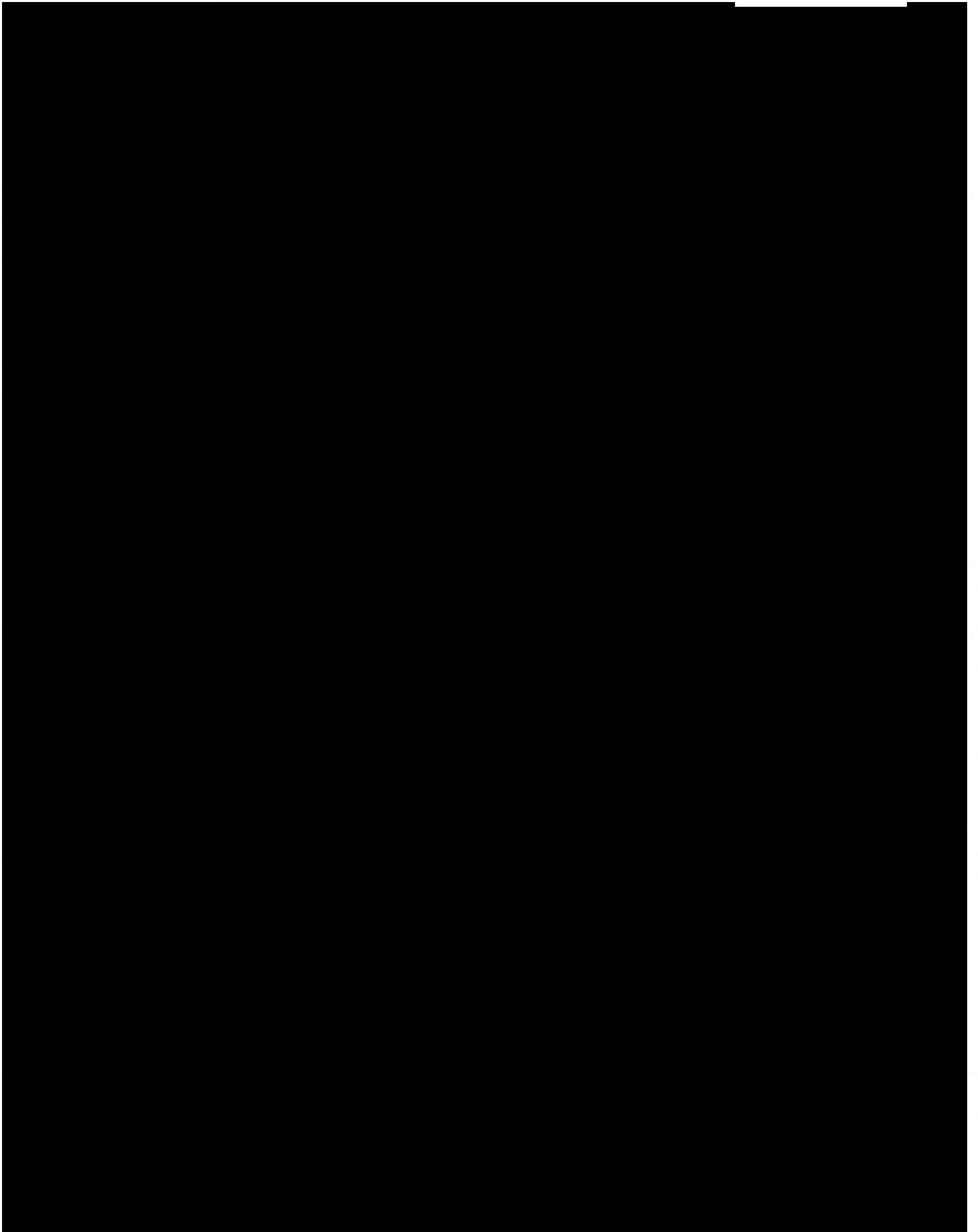

Pennsylvania Gross Receipts

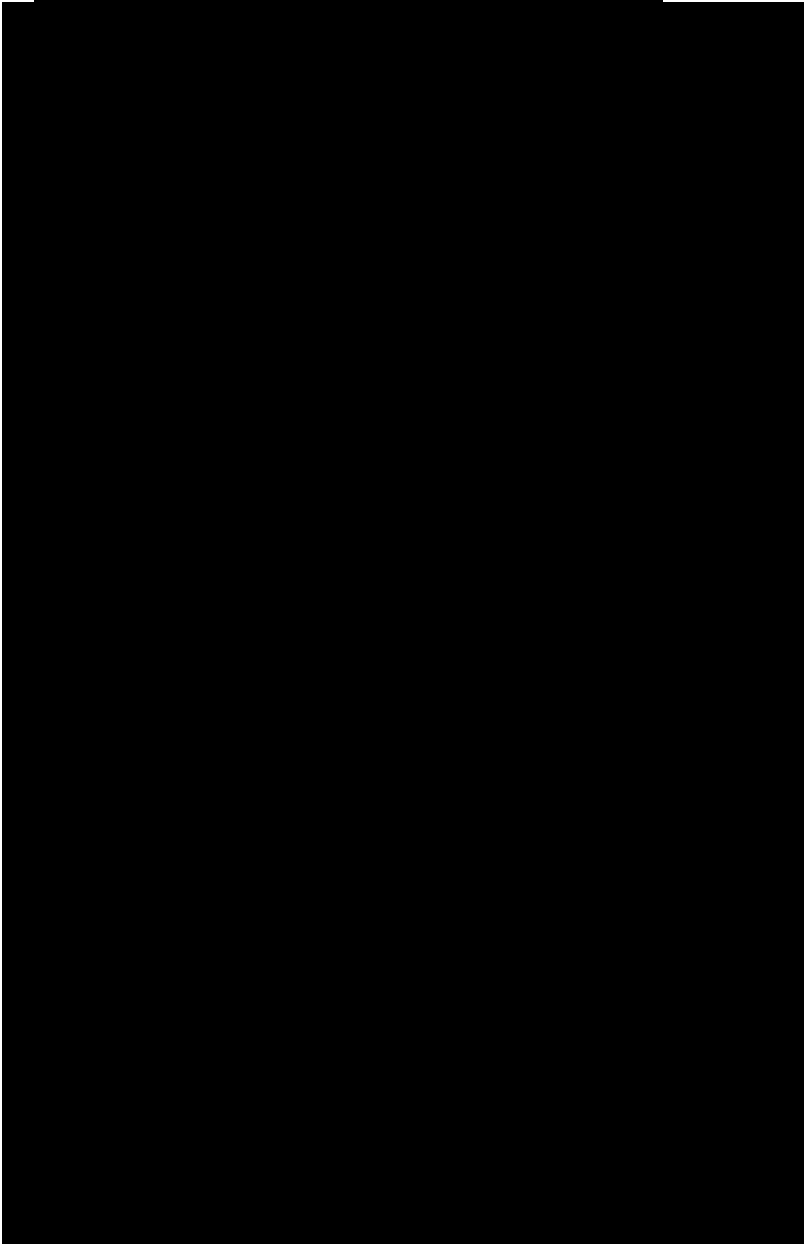
