**SUPPLEMENT TO THE PETITION OF CONNECT EVERYONE LLC, A WHOLLY-
OWNED SUBSIDIARY OF STARRY INC., FOR DESIGNATION AS AN ELIGIBLE
TELECOMMUNICATIONS CARRIER FOR RURAL DIGITAL OPPORTUNITY FUND
PHASE I SUPPORT**

Connect Everyone LLC and Starry, Inc. (collectively “Starry” or the “Petitioner”) respectfully submit this Supplement to the above-captioned Petition for Designation as an Eligible Telecommunications Carrier (“ETC”) filed with the Pennsylvania Public Utility Commission of Pennsylvania (“Commission”) on January 29, 2021 (“Petition”). This Supplement is submitted to clarify the roles and commitments of Connect Everyone LLC and Starry, Inc., in connection with ETC status in Pennsylvania.

This Supplement confirms that Connect Everyone LLC is a wholly-owned subsidiary of Starry, Inc. To clarify the relationship between Starry, Inc. and Connect Everyone LLC for consumers, Connect Everyone LLC will register the Fictitious Name “Starry” and will provide broadband and voice service in the Proposed ETC Service Areas, as set forth in Exhibit A to the Petition, under the Starry brand name. All customer-facing terms of service, including customer contracts, will disclose that Connect Everyone LLC d/b/a Starry is a wholly-owned subsidiary of Starry, Inc. The voice and broadband services provided by Connect Everyone LLC d/b/a Starry will utilize Starry Inc.’s hybrid fiber point-to-multipoint fixed wireless network and spectrum licenses. Connect Everyone LLC d/b/a Starry also will use the financial, technical, and operational resources of Starry, Inc., to deploy service to its Proposed ETC Service Areas.

This Supplement further confirms that both Connect Everyone, LLC, and Starry, Inc. attest to and verify all statements made in the ETC Petition and the Responses to Data Requests submitted in this docket. Connect Everyone LLC and Starry, Inc. commit to making all reasonable efforts to fully comply with all obligations and conditions required of ETC designees in the Commonwealth. Starry, Inc., as the 100% owner of Connect Everyone LLC, further

confirms that it will be fully financially and operationally responsible for Connect Everyone LLC, and hereby guarantees and ensures in all respects Connect Everyone LLC's financial commitments, compliance obligations, and operational commitments associated with ETC status in the Commonwealth. Starry, Inc. hereby agrees to submit itself to the Commission's jurisdiction to the extent permissible by law for the purposes of enforcement of Connect Everyone LLC's ETC commitments and obligations and of Starry, Inc.'s guarantee of those commitments and obligations.
