KNOW ALL MEN BY THESE PRESENTS, That Fairview Township, a municipal authority of Pennsylvania hereinafter called "GRANTOR," intending to be legally bound, does hereby for itself, its successors and assigns, grant unto PPL Electric Utilities Corporation, hereinafter called "COMPANY" its successors and assigns, the right, privilege and authority to cut down and any all trees within twenty-five (25) feet each side of centerline of the electric/communication line and the right to trim any and all trees within twenty-five (25) feet each side of centerline of the electric line and to remove brush along said lines which in the judgment of the said Company menace the said lines; on property identified as County Tax Parcel No. 27000QF00230000000; as shown on plan hereto attached and made a part hereof which the undersigned owns or has any interest located along Lewisberry Road situate in the Township of Fairview, County of York, Commonwealth of Pennsylvania.

A copy of this agreement and an acceptance hereof by PPL shall be filed by PPL with the Pennsylvania Public Utility Commission, and this agreement shall thereafter become effective in accordance with the provisions of the Public Utility Law.




