NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): Eight (8) hours at rates named in Columns 1 and 2. Weekdays (any hour): Three (3) hours at rates named in Columns 1 and 3. Saturday (any hour): Three (3) hours at rates named in Columns 1 and 4.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.
