LUSSO EXECUTIVE TRANSPORTATION SERVICE, LLC
Data Request Responses

1. Drivers for Lusso Executive Transportation Service, LLC (“Lusso”) will be employees of Lusso, and all vehicles will be company-owned vehicles. All drivers will have past rideshare and/or limousine experience, and shall have maintained an above-average rating during their previous experience. All vehicles shall be Tesla-model vehicles with enhanced safety features, and all will comply with federal, state, and local laws, statutes, and regulations pertaining to the operation of a motor vehicle, including licensing, registration, and insurance regulations and requirements. However, as of the date of this correspondence, Lusso only has one driver, being company owner Tom Dongilla, and one vehicle, being a Tesla Model X.
2. All drivers for Lusso shall be 25 years of age or older. While Pennsylvania Public Utility Commission generally allows drivers to be at least 18 or 21 years of age, Lusso has elected to only employ drivers who are 25 years of age or older.
3. Prior to hiring any driver, and annually thereafter, Lusso will obtain and review a criminal history research report for such person. The criminal background check will be a national criminal background check including the national sex offender database. Any person who has been convicted, within the past seven years, of driving under the influence of drugs or alcohol, or who has been convicted at any time for fraud, sexual offenses, use of a motor vehicle to commit a felony, a crime involving property damage, and/or theft, acts of violence, or acts of terror shall not be permitted to be an employee of Lusso. Lusso will, at all times, comply with federal, state, and local laws, statutes, and regulations, including 66 Pa.C.S. § 2601, et seq., and 52 Pa. Code § 29.1, et seq.
4. In addition to ensuring that all Lusso drivers possess an active, valid Pennsylvania driver’s license, Lusso shall establish a driver-training program designed to ensure that each driver safely operates his or her vehicle prior to the driver being able to offer service. Lusso will require that all Lusso drivers pass a nationally accredited online driver training course, including such modules as: defensive driving, distracted driving, collision prevention, safe driving habits, and community safety education. Additionally, each driver shall be required to take training courses pertaining to the use of GPS and navigation in their vehicle.
5. Lusso shall implement a zero-tolerance policy on the use of drugs or alcohol applicable to any driver, provide notice of the zero tolerance policy to each driver, as well as the procedures to report a complaint about a driver with whom the passenger was matched and for whom the passenger reasonably suspects was under the influence of drugs or alcohol during the course of the ride, and immediately deactivate said driver’s access to act as a driver for Lusso. The suspension shall last the duration of the investigation. Similarly, any accident that occurs by a Lusso driver shall be fully investigated, and any such driver will have their privileges suspended for the duration of the investigation. Lusso will take any measure it deems appropriate, including terminating the employment of such driver, upon the findings of the investigation.

6. Prior to hiring a driver with Lusso, and annually thereafter, Lusso will ensure that all vehicles are properly inspected and compliant with all applicable vehicle regulations, including registration and emissions requirements. Additionally, all passengers in each vehicle shall be required to wear their seat belts at all times, each driver will operate the vehicle with the utmost safety, and shall at all times comply with all operation and road laws, rules, and regulations. All vehicles will be four-door vehicles that are no greater than ten (10) years old, have working windows and air conditioning, and have no cosmetic damage or commercial branding.

I, Tom Dongilla, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief, and that I expect to be able to prove the same at a hearing held in this matter. 
