## I. <u>INTRODUCTION</u>

The Office of Small Business Advocate ("OSBA") is authorized to represent the interests of small business customers of utility services before the Pennsylvania Public Utility Commission ("PUC" or the "Commission") pursuant to the provisions of the Small Business Advocate Act, Act 181 of 1988, 73 P.S. §§ 399.41 – 399.50 ("the Act"). In order to discharge this statutory duty, the Small Business Advocate deems it necessary to participate as a party to this proceeding.

#### II. FILING BACKGROUND

On May 14, 2021, Aqua Pennsylvania Wastewater, Inc. ("Aqua" or the "Company") filed an Application for approval of the acquisition of the wastewater system assets of Lower Makefield Township ("LMT").

On June 9, 2021 the OSBA filed a Notice of Appearance, Notice of Intervention, and Public Statement.

The Commission's Bureau of Investigation and Enforcement ("I&E") filed its Notice of

Appearance on June 16, 2021.

The Application was conditionally accepted by the Commission on June 25, 2021.

LMT filed a Petition to Intervene on June 29, 2021.

On July 2, 2021, the Office of Consumer Advocate ("OCA") filed a Protest and Public

Statement.

On August 2, 2021, John Char filed a Protest opposing the Application.

The Commission accepted the Application on August 5, 2021.

On August 5, 2021, Barry Summers filed a Protest, requesting that the Application be denied.

By Order dated August 11, 2021, a telephonic prehearing conference was scheduled for

September 9, 2021 before Administrative Law Judge ("ALJ") Jeffery A. Watson.

On August 13, 2021, Kevin Cauley and Beth Cauley jointly filed a Protest, requesting that the Application be denied.

On August 18, 2021, Aqua filed a Petition for Protective Order.

On August 24, 2021, ALJ Watson issued an Interim Order directing Protestants, Barry

Summers, Kevin Cauley and Beth Cauley to file a responsive pleading or objections to the Petition

Of Aqua Pennsylvania Wastewater, Inc For Protective Order by August 31, 2021.

On August 25, 2021, Jaan Pesti filed a Protest opposing the Application.

On August 27, 2021, Peter Lachance filed a Protest opposing the Application.

On September 3, 2021, ALJ Watson issued an Order granting Aqua's Petition for Protective Order

The OSBA will participate in the case to assure that the interests of small business customers of Aqua are adequately represented and protected.

As appropriate and necessary, the OSBA will investigate and analyze the claims and proposals of the Company and other parties through cross-examination of witnesses appearing for

those parties and through briefing. The OSBA will particularly focus on any issue where the impact on the interests of the small business consumers would be unjustifiably different than or disproportionate to the impact on another class of customers, or otherwise lacking in reasonableness or basic fairness. The OSBA will also focus on the rates applicable to acquired customers following the closing of the proposed acquisition, including how long such rates are proposed to remain in effect. The OSBA submits that further information is required to determine the impact on small business customers.

The OSBA reserves the right to pursue additional issues after reviewing the testimony of the parties and as issues arise throughout the proceeding.
