Please make the change on your end so that we receive the correct PUC Assessment Report next year.

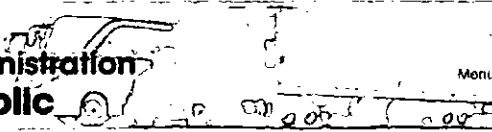
