**MOTION OF THE OFFICE OF CONSUMER ADVOCATE
FOR THE ADMISSION OF TESTIMONY**

Pursuant to Section 5.103 of the Commission’s Regulations, 52 Pa Code § 5.103, the Office of Consumer Advocate (OCA) hereby files this Motion for the Admission of Testimony and Exhibits (Motion) in the above-captioned proceedings. By way of this Motion, the OCA seeks to admit OCA Statement 3R into evidence. In support of the Motion, the OCA represents as follows:

1. OCA Statement 3R, the Rebuttal testimony of Jerome D. Mierzwa, was pre-served upon the Presiding Officer and all parties on August 27, 2021, in accordance with the procedural schedule, and accompanied by a verification.
2. During the Evidentiary Hearing held on September 8, 2021, the testimony and exhibits identified in Joint Hearing Exhibit 1 were admitted into the record of this proceeding.
3. OCA Statement 3R, the Rebuttal testimony of OCA witness Jerome D. Mierzwa, was inadvertently omitted from Joint Hearing Exhibit 1.
4. The Presiding Officer and all active parties participated in a conference call addressing procedural matters on September 9, 2021. All parties indicated no opposition to admission of OCA Statement 3R into the evidentiary record.

5. As directed by the Presiding Officer, the OCA submits this Motion requesting admission of OCA Statement 3R.

Wherefore, the OCA, by its counsel, respectfully requests that Administrative Law Judge Dennis J. Buckley grant this unopposed Motion and admit into the evidentiary record OCA Statement 3R, the Rebuttal Testimony of Jerome D. Mierzwa.
