

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier. Supervisor hourly rates will be charged at \$3.00 above additional men hourly rate.

▲ NOTE 6 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
