

PECO Energy Company ("PECO"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. A telephonic hearing in this matter is scheduled to take place on Wednesday, September 30, 2021 at 10:00 a.m.
2. PECO is requesting a continuance of the September 30, 2021, hearing date because Respondent's counsel, Edward Fisher, is on an indefinite medical leave of absence.
3. Co-counsel, Angela Lorenz, Esquire, will enter an appearance on this matter, but is currently scheduled in another judicial proceeding on September 30, 2021 at 10:00 a.m.
4. PECO therefore respectfully requests that the hearing be continued to a future date, thirty (30) days from today.
5. The Prehearing Order in this matter states that requests for a continuance are only granted "in rare situations where good cause exists." (Prehearing Order, citing 52 Pa. Code § 1.15).
6. PECO avers that "good cause" exists to continue the scheduled hearing to another date because of an unexpected medical leave of absence. Co-counsel is currently scheduled in another judicial forum at the time and date of the Hearing.

7. PECO has informed the Complainant that a continuance will be requested.
8. The Complaint does not have an objection to the Continuance request.
9. PECO therefore respectfully requests that the hearing be continued to a further date.
