▲ NOTE 1 - MINIMUM CHARGES: Sundays & Holidays (any hour) and Monday-Saturday (6:01PM-5:559AM): Four (4) hours at rates named in Column 2 plus applicable travel charge. Monday-Saturday (6:00AM-6:00PM): Three (3) hours at rates named in Column 3 plus applicable travel charge for crew less than three (3) men and four (4) hours at rates named in Column 3 plus applicable travel charge for crew of three (3) men or more.

▲ NOTE 2 - When a spinet or upright piano, safes (250 pounds and up), furniture weighing 300 pounds and over, or hot tubs and other bulky items 350 pounds and over are part of a move, a flat charge of \$150.00 will be assessed in addition to the hourly rates shown above. A charge of \$250.00 will be assessed for a spinet or upright piano when moved 7 steps or more.

▲ NOTE 3 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges. This note is applicable to moves transported 40 miles and less and moves transported in excess of 40 miles.

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns 2 and 3 will apply if the road miles from the carrier's terminal to the point of origin and from point of destination to carrier's terminal total 30 miles or less. A flat charge based on two hours at the applicable transportation rates shown in Columns 2 and 3 will apply if the road miles from the carrier's terminal to the point of origin and from the point of destination to the carrier's terminal total 31-60 miles. Should the actual distance from the carrier's terminal to the point of origin and from the point of destination to the carrier's terminal exceed 60 miles, an additional charge based on one-half hour of travel time for each additional 15 miles increment will apply.
