We represent Lower Makefield Township (the “Township”) in the above-referenced matter. The Township supports and joins Aqua Pennsylvania Wastewater, Inc.’s (“Aqua”) Main Brief regarding the ratemaking rate base for the Township’s system filed on October 8, 2021. For all of the reasons set forth in Aqua’s Main Brief, the Township respectfully submits that – pursuant to section 1392(c)(2) of the Public Utility Code – the ratemaking rate base is \$53,000,000, being the lesser of the negotiated purchase of \$53,000,000 and the average of Utility Valuation Experts’ appraisals of \$54,967,796.
