This letter serves as notice to the Pennsylvania Public Utility Commission (“PAPUC”) that MP2 Energy NE LLC (“MP2”) intends to use a new trade name, Shell Energy Solutions, effective as of October 6, 2021. MP2 registered the trade name with the Pennsylvania Department of State on June 14, 2021. Documentation associated with those registrations is attached as Attachment A.

No corporate or organizational changes to MP2 have occurred. MP2 remains the same standalone corporate entity and its DUNS number and Federal Taxpayer Identification Number remain the same. Additionally, MP2’s use of the trade name does not change the terms and conditions pursuant to which the PAPUC has licensed MP2. The use of the trade name does not change MP2’s services or customer population and does not change MP2’s financial, technical or managerial capabilities.
