NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 2 hours at rates named in Columns 1 and 2 plus applicable travel charge. Saturdays (any hour) or Weekdays, (6:01PM to 6:59AM): 2 hours at rates named in Columns 1 and 4 plus applicable travel charge. Weekdays (7:00AM to 6:00PM): 2 hours at rates named in Columns 1 and 3 plus applicable travel charge.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested or required. Hourly charge for each supervisor will be the driver rate plus \$10.00 per hour.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.


