**PETITION OF MASTHOPE MOUNTAIN COMMUNITY ASSOCIATION TO WITHDRAW
INTERVENTION PETITIONS AND PROCEED AS FORMAL COMPLAINANT**

Masthope Mountain Community Association (“Masthope”) files its petition to withdraw its intervention petitions filed in the above captioned matters given that Masthope is proceeding as a formal complainant and active party in the consolidated water and wastewater rate proceedings.

1. Aqua Pennsylvania, Inc. and Aqua Pennsylvania Wastewater, Inc. (together “Aqua PA”) filed Original Tariff Water – PA P.U.C. No. 3 (“Tariff Water No. 3”) and Original Tariff Sewer – PA P.U.C. No. 3 (“Tariff Sewer No. 3”) on August 20, 2021, to become effective on October 19, 2021.

2. On October 6, 2021, Masthope filed formal complaints docketed at C-2021-3028992 (Water) and C-2021-3028996 (Wastewater) and separately petitioned to intervene in both water and wastewater rate cases.

3. By Order entered October 7, 2021, the Commission instituted investigations to determine the lawfulness, justness and reasonableness of the rates, rules and regulations contained in Aqua’s proposed water and wastewater tariffs. The tariffs were suspended by

operation of law until May 22, 2022, and both matters were assigned to the Office of Administrative Law Judge, with ALJ Mary Long serving as the Presiding Officer.

4. The President Officer held a prehearing conference on October 15, 2021, during which the Presiding Officer requested that Masthope proceed either as a formal complainant or intervenor.

5. Given that Masthope filed formal complaints and is proceeding as a formal complainant and active party in the consolidated water and wastewater rate proceedings, Masthope withdraws its intervention petitions filed in the above captioned matters.

6. Masthope will maintain active party status and reserves any and all rights of a formal complainant.

WHEREFORE, Masthope requests that the Presiding Officer issue an order granting this petition.


