▲ NOTE 1 - MINIMUM CHARGES: Sundays & Holidays (any hour): Three (3) hours at rates named in Columns 2 plus applicable travel charge. Saturdays (any hour) and Monday-Friday (6:01PM-7:59AM): Two (2) hours at rates named in Column 4 plus applicable travel charge. Monday-Friday (8:00AM-6:00PM): Two (2) hours at rates named in Column 3 plus applicable travel charge.

▲ NOTE 2 - When a spinet or console piano is included in the shipment, an additional charge of \$150.00 per piano will be assessed in addition to all other applicable charges. Carrier does not move upright, player, baby grand, or grand pianos.

▲ NOTE 3 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges. This note is applicable to moves transported 40 miles and less and moves transported in excess of 40 miles.

▲ NOTE 4 - When requested or required, carrier will supply a supervisor to oversee the move. Cost for supervisor is driver rate per hour shown above plus an additional \$4.00 per hour.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
