**PETITION OF TIME WARNER CABLE
INFORMATION SERVICES (PENNSYLVANIA), LLC
TO AMEND ETC DESIGNATED SERVICE AREA**

Time Warner Cable Information Services (Pennsylvania), LLC (“TWCIS”) hereby petitions the Pennsylvania Public Utility Commission (the “Commission”) to revise TWCIS’s Eligible Telecommunications Carrier (“ETC”) designated service area by removing the census blocks identified in **Exhibit 1** hereto so that the service area will remain consistent with the areas that are eligible for support from the FCC’s Rural Digital Opportunity Fund (“RDOF”) as reflected in **Exhibit 2** hereto. In support of this Petition, TWCIS submits the following:

I. BACKGROUND

In December 2020, the FCC named CCO Holdings, LLC (“CCO Holdings”), an affiliate of TWCIS, a winning bidder of support in the “Phase I” auction of its RDOF program.¹ As the assignee of that support in Pennsylvania, TWCIS will receive federal RDOF support to expand the broadband network owned and operated by Charter Communications, Inc. and its affiliates into certain rural census blocks in Pennsylvania that are currently unserved by high-speed broadband service (the “RDOF Census Blocks”). As a condition to receiving the RDOF support, TWCIS was

required to become an ETC in the areas for which it will receive RDOF support. As a result, in January 2021, TWCIS filed its Petition with the Commission seeking designation as an ETC only in the RDOF Census Blocks (identified in Exhibit A to its ETC Petition).

Both TWCIS and the FCC recognized that the Phase I auction (as well as the RDOF program generally) relied on imperfect data to identify unserved areas and could include areas that would turn out not to be suitable for network expansion or RDOF support; therefore, it was likely that RDOF support would ultimately not be awarded for at least some census blocks that were included in the Phase I auction. To account for this contingency, TWCIS's Petition and other filings in this docket made clear that TWCIS was only seeking designation as an ETC in the RDOF Census Blocks in order to support its RDOF obligations and that TWCIS's ETC designated service area should at all times remain consistent with any changes that the FCC made to the RDOF Census Blocks.²

On July 15, 2021, the Commission issued its order (the "ETC Designation Order") granting TWCIS's Petition and designating it as an ETC in a list of defined census blocks (the "ETC Census Blocks") that tracks the RDOF Census Blocks as identified in TWCIS's ETC Petition. Those ETC Census Blocks were reflected Appendix A to the ETC Designation Order.

II. REQUEST FOR ETC CENSUS BLOCK MODIFICATION

After the ETC Designation Order was entered, the FCC issued public notices and letters indicating that RDOF recipients will not receive RDOF support in certain census blocks and/or asking RDOF recipients to review their winning census blocks and to return any census blocks

that should not be included in the RDOF program.³ Additionally, TWCIS has informed FCC staff of census block groups in Pennsylvania originally won in the RDOF auction by CCO Holdings for which TWCIS is no longer applying for RDOF support. TWCIS expects that the FCC will publicly notice this information at a later date. The census blocks which will no longer be included in the RDOF program are identified in Exhibit 1 hereto. Because TWCIS will not receive RDOF support for these census blocks, TWCIS now seeks to amend its ETC Census Blocks to remove those census blocks from its ETC designated service area. Exhibit 2 hereto provides a revised list of the remaining census blocks for which TWCIS should remain designated as an ETC in Pennsylvania.

III. CONCLUSION

For these reasons, TWCIS respectfully requests that the Commission grant this Petition and remove the census blocks identified in Exhibit 1 from the list of the census blocks reflected in Appendix A to TWCIS's ETC Designation Order, and issue an amended Appendix A to the ETC Designation Order to reflect only the census blocks listed in Exhibit 2 hereto as the census blocks in which TWCIS is designated as an ETC in Pennsylvania.


