Hundreds of constituents have contacted my office expressing strong opposition to Aqua's request. Many of our residents are seniors living on fixed incomes and a number of individuals are still recovering, financially, from the impact of the pandemic. Aqua's untimely request for a significant rate increase, for this basic necessity, places many residents in a financially stressful situation.

This request is particularly concerning to a large number of households in the district that received an increase in their wastewater rates as recently as last year due to a wastewater utility sale.
