Dear Secretary Chiavetta:

Community Utilities of Pennsylvania Inc. Water and Wastewater Division ("CUPA") hereby requests that the page limit for briefs on material question be extended to forty (40) pages to allow the parties to adequately address the issues raised in the November 9, 2021 Order Rejecting the Proposed Joint Settlement and Certifying a Material Question to the Commission ("the Order") in the above referenced matters. The Bureau of Investigation and Enforcement (I&E), the Office of Consumer Advocate ("OCA"), and the Office of Small Business Advocate ("OSBA") do not oppose the request for extension.

This general rate base proceeding has a large record. The Order is 37 pages long and omits to include or discuss portions of material record evidence, the parties' statements in support of settlement, and stipulation of facts contained in the October 12, 2021 Joint Petition for Settlement, among other things. Due to the complexity and requirement that the parties address all matters raised in the Order which rejects the Joint Settlement of all issues entered into by CUPA, I&E,

OCA, and OSBA, CUPA respectfully requests that the Commission extend the briefing page limit to 40 pages to allow the parties to adequately address all matters raised in or omitted from the Order.
