Petition to reduce bonding levels to 5%.

Secretary Chiavetta,

Shiple Choice has been licensed as an Electric Generation Supplier since Dec 2012. Shiple Choice filed its initial petition to reduce its bonding level to 5% of its gross receipts and was approved by the Commission in March 2017. Shiple Choice subsequently filed renewable petitions each year, and each was granted. In 2021 however, our Petition was filed late and Shiple withdrew its renewal Petition rather than have the Commission reject it. Shiple has provided the full 10% rider bond to the Commission as of Aug 29, 2021.

Shiple Choice hereby submits a new Petition for a reduction of its bonding requirement from 10% to 5% of its annual gross receipts. Accordingly, please accept this letter as our request to reduce our security level to 5% of our most recent 4 quarters of gross receipts, in accordance with the Final Order entered July 24, 2014, at Docket No. M-2013-2393141.
