Dear Mr. Weaver:

Per our conversation during the Formal Complaint hearing, held on December 1, 2021, this letter confirms the settlement of the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve your formal complaint as follows:

- Your account will be credited \$2500.00 towards the outstanding balance of \$9,466.33.
- You will pay off your remaining balance of \$6,966.33 over the course of a 36-month payment agreement in installments of \$193.51 per month starting with your January 2022 bill.
- All current monthly bills must be paid on time and in full, in addition to your monthly agreement installment of \$193.51, in order to avoid late payment fees being assessed on your account.

This letter memorializes the entire agreement between you and PECO Energy Company. Any other terms or promises, written or oral, not in the body of this letter will not be a part of this settlement agreement and, therefore, will be void.

A Certificate of Satisfaction will be forwarded to the PUC to inform them of the status of this complaint. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will sufficiently confirm to the PUC that the Complaint has been resolved and the file will be closed.
