Petition is made on behalf of Matt Toney, Owner/Operator of Exceptional Movers LLC

I hereby petition for reconsideration for application A-8919919; A-2021-3029208 that was denied on the grounds to demonstrate Under 52 Pa. Code 3.381 that I failed to provide adequate evidence that I collaborated with a licensed household goods mover. Code 3.381 states that I can meet this requirement by possessing the equivalent. I possess extensive knowledge, skills and over 7 years' experience in the moving industry to demonstrate my qualifications for authority under the PUC.

1. In 2014 I (Matt Toney) had created Exceptional Movers, a moving labor business which I have been immersed with hands-on skills and knowledge of the moving industry. I acquired strategic experience with tier loading left to right and tying down sections onto trucks, unloaded customers belongings to specific locations throughout homes with taking precaution of walls, doors, floors also windows. I Provided special box packing services of delicate items, stretch wrapping of furniture, proper furniture handling with disassembling and reassembling of Gym equipment, appliances and furniture. During my building of Exceptional Movers, I have trained and guided crews in assisting customers with loading and unloading of their rental trucks, Pods, U-boxes or personal vehicles. I have moved specialty items such as Pianos, Pool tables, Hot tubs, Safes, treadmills, Appliances also bathroom Vanities which need to be strategically and

safely managed in and out of homes, offices, Trucks or on-site with dollies and hand trucks.
