Re: REPLY TO EXCEPTION OF PPL ELECTRIC UTILITIES CORPORATION TO THE INITIAL DECISION in the case of Lloyd and Susan Horst v. PPL Electric Utilities Corporation Docket No. C-2021-3026448

Dear Secretary Chiavetta:

We are responding to PPL's Exception to the Initial Decision which PPL filed on December 6, 2021. In that decision ALJ Eranda Vero ordered:

"That the Secretary's Bureau shall file the present formal Complaint under Docket No. C-2018-3006774 and identify it as a petition for reconsideration of the Commission's Final Order in that matter."

In its Exception PPL again goes on at length repeating arguments it made in their Preliminary Objections, and its Answer and New Matter which we examined closely and refuted in our filings dated July 27, 2021 and August 2, 2021. In the very "interest of administrative efficiency and judicial economy" which PPL claims to value so highly but fails to honor, we simply state for the record that PPL does not acknowledge the ruling in Povacz et. al. of October 8 2020 as asserting that smart meters are not mandated.

Nor is PPL content to wait until the PA Supreme Court decides the case on appeal, and on which the Supreme Court is hearing oral arguments Tuesday of this week. .

Administrative efficiency and judicial economy would dictate, in our view, that we dispense with more filings until the PA Supreme Court decides on the case.




