NOTE 1 - When a Holiday falls on a Saturday, the rates named in Columns 1 and 3 shall be applicable.

NOTE 2 - Minimum total transportation charges: Sundays and Holidays: 8 hours at rates named in Columns 1 and 3.

NOTE 3 - Minimum total transportation charges: Saturdays and Weekdays (5:31PM to 6:00AM): 4 hours at rates named in Column 2 plus applicable travel charge.

NOTE 4 - Minimum total transportation charges: Weekdays 6:01AM to 5:30PM: 4 hours at rates named in Columns 4 plus applicable travel charge.

NOTE 5 - For shipments transported distances of 40 miles and less between points in Pennsylvania, the following travel charges will apply:

- ( 1 ) If the origin point and destination point are both 10 miles or less air miles from the carrier's terminal, travel charge is one (1) hour at the applicable rates.
- ( 2 ) If either the origin or destination point is located within an area that is over 10 air miles but not exceeding 15 air miles from the carrier's terminal, the travel charge is one and one-half (1 1/2) hours at the applicable rates.
- ( 3 ) If either the origin or destination point is located within an area that is over 15 air miles but not exceeding 25 air miles from the carrier's terminal, the travel charge is two (2) hours at the applicable rates.
- ( 4 ) If either the origin or destination point is located within an area that is over 25 air miles (up to 40 air miles) from the carrier's terminal, the travel charge is three (3) hours at the applicable rates.
- ( 5 ) If either the origin or destination is located within an area in excess of 40 air miles from the carrier's terminal, the travel charge is three (3) hours plus one-half (1/2) hour for each additional 15 air miles over 40 air miles.
