Dear Secretary Chiavetta:

By Order entered November 18, 2021 in the above-captioned rate case proceeding, the Commission approved the Joint Petition for Settlement ("Settlement") filed by the Pittsburgh Water and Sewer Authority ("PWSA" or "Authority"), the Bureau of Investigation and Enforcement, the Office of Consumer Advocate, the Office of Small Business Advocate, Pittsburgh United and the City of Pittsburgh. Pursuant to Section III.E.6.d of the Settlement, PWSA agreed to file a Damaged Sewer Lateral ("DSL") Plan for the Commission's approval within 90 days after entry of the Final Order in this proceeding.

Per the terms of the Settlement, PWSA's DSL Plan is currently due on February 16, 2022. The purpose of this letter is to request a 30-day extension of time, making the DSL Plan due on March 18, 2022. PWSA is authorized to represent that the parties to the Settlement do not object to this requested extension of time. While PWSA has drafted a comprehensive outline of the DSL Plan and met with the parties to discuss its components, the additional time will enable further collaborative discussions and give the Authority an adequate opportunity to ensure that the parties' feedback is reflected in the filing that is made with the Commission.

For these reasons, PWSA requests that the Commission grant it an extension of time to file a DSL Plan by March 18, 2022.
