NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour (15 minutes) periods; fractions of one-quarter hour (15 minutes) considered as one-quarter hour (15 minutes).

◆ NOTE 4 - Minimum Transportation Charge: Sundays and Holidays: 6 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (any hour): 4 hours at rates named in Column 1 and Columns 3 or 4.

◆ NOTE 5 - When requested or required, additional cost to hold shipment overnight is \$350.00 per night with the first night being provided at no charge. Anticipated number of nights payable at origin. Additional nights, if required, payable upon delivery at destination.

NOTE 6 - Toll charges for any bridge, tunnel, ferry or highway incurred by the mover between origin and destination of the move, as well as, parking fees incurred by the mover will be the responsibility of the shipper and added to the moving charges.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage.

0 - 20 miles	1.0 hour
21 - 30 miles	1.5 hours
31 - 40 miles	2.0 hours
41 - 50 miles	2.5 hours
51 - 75 miles	3.5 hours
76 - 100 miles	4.0 hours

For mileage in excess of 100 miles, a travel time charge of .5 hour will be assessed for each additional 10 miles or portion thereof.
