To transport, as a common carrier, by motor vehicle, persons in paratransit service from points in Berks County, to points in Pennsylvania, and return.

To transport as a common carrier, by motor vehicle, persons in paratransit service from points in the Counties of Dauphin, Lancaster, Lebanon, and York to points in the Commonwealth of Pennsylvania and return.

## **RULES AND REGULATIONS**

### **1. ADVANCE RESERVATIONS:**

Advance reservations must be made 24 hours prior to the service being rendered.

### **2. HOURLY RATES:**

Rates begin from the time vehicle leaves carrier's place of business and ends at the time vehicle returns to carrier's place of business.

### **3. ADDITIONAL EXPENSES:**

All bridge, road, and tunnel tolls, parking/entrance fees, and other out-of-pocket expenses shall be the responsibility of the customer and will be added onto carrier's charges.

### **4. CONTRACT:**

Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

**SCHEDULE OF RATES**  
**(Per Person, One Way)**

**Base Rate (per person) - One Way Trips:**

**Regular Service** (Monday through Sunday, 6:00AM to 6:00PM)

- Ambulatory Rate:	\$30.00 per passenger, ambulatory
Wheelchair van/minibus:	\$40.00 per passenger

**Evening Hours** (Monday through Sunday, 6:01PM to 5:59AM following day)

Ambulatory Rate:	\$40.00 per passenger, ambulatory
Wheelchair van/minibus:	\$50.00 per passenger

**Mileage Rate**

Applies in addition to the base rates stated above on all loaded miles after the first 10 miles from the point of pick-up to the point of drop-off.

\$3.00 per additional mile, or any fraction thereof.

**Waiting Time**

Waiting time during which the driver or crew must wait for the passenger at the point of pick-up or drop-off shall be charged at the rate of \$5.00 for each 15 minutes or fraction thereof.
