Dear Secretary Chiavetta:

On January 13, 2022, Duquesne Light Company (“Duquesne Light” or the “Company”) filed its *Petition for Approval to Modify its Supplier Master Agreement* (“Petition”) and supporting Exhibits at the above-captioned docket. The Petition indicated that the Company would “make an informational filing at this docket once PJM publishes its revised BRA [Base Residual Auction] schedule, expected to occur on January 21, 2022, to update the Commission and parties of PJM’s then-current BRA schedule.” Petition FN15, *see also* Petition FN13. This letter constitutes the informational filing identified in the Petition.

On January 21, 2022, PJM filed its *Compliance Filing Concerning Certain Proposed Revised Pre-Auction Deadlines and Motion for a Shortened Comment Period of 7 Days and Request for Expediated [sic] Consideration* (“PJM Compliance Filing”) at FERC Docket Nos. EL19-58 *et al.* In relevant part, the PJM Compliance Filing “propose[s] a new schedule for RPM Auctions and associated pre-auction deadlines through the 2026/2027 Delivery Years.” PJM Compliance Filing p. 1. PJM proposed the following BRA schedule:

2024/25	Aug 2022	Dec 2022	1 st and 2 nd

2027/28 <small>(back on schedule)</small>	May 2024	May 2024	

PJM Compliance Filing p. 9. This proposed schedule is consistent with the Company’s expectation that the BRA for the 2023/2024 Delivery Year will probably not be concluded before the Company’s March 14, 2022, default supply procurement. *See* Petition ¶¶ 23, 26.
