1. By notice dated December 29, 2021, the Commission scheduled an Initial Telephonic Hearing in this matter for Thursday, February 10, 2022 at 10:00 a.m., before Special Agent Alphonso Arnold, III.
2. Pursuant to 52 Pa. Code §5.231(a), PGW has contacted Ms. Martinez and is attempting to reach a settlement in this matter.
3. It is unlikely that a resolution will be reached prior to the scheduled hearing date.
4. PGW has spoken with Ms. Walker and discussed continuing this matter.
5. Ms. Martinez agrees that the hearing should be continued to allow more time to reach a settlement and has no objection to PGW’s Motion.
