

Attached are updates for 467th Revised Page 2, 235th Revised Page 2-A, 84th Revised Page 5-A, 2nd Revised Page 53-C, and Original Page 53-C-1 for Haverford Movers, LLC (PA PUC Certificate #A-8913834) in Havertown PA. Other than Sundays & Holidays (any hour): Non-Peak Season (September 15th thru May 14th): 4 hours at rates named in Columns 1 and 3. Other than Sundays & Holidays (any hour): Peak Season (May 15th thru September 14th): 5 hours at rates named in Columns 1 and 3.

NOTE 3 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

▲ NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in columns 2 or 3 when distance from original point of origin to final destination is 20 miles or less.

A flat charge based on one and one half hours at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is more than 20 miles but not exceeding 30 miles.

A flat charge based on two hours at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is more than 30 miles but not to exceed 40 miles.
