

Attached are updates for 466th Revised Page 2, 48th Revised Page 2-C, 78th Revised Page 7, 4th Revised Page 106-D, and Original Page 106-D-1 for Wall's/Delaware Valley Havertown/Westtown Movers, LLC (PA PUC Certificate #A-8910987) in Havertown PA. ▲ NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays & Holidays (any hour): 5 hours at rates named in Columns 1 and 2. Other than Sundays & Holidays (any hour): Non-Peak Season (September 15th thru May 14th): 4 hours at rates named in Columns 1 and 3. Other than Sundays & Holidays (any hour): Peak Season (May 15th thru September 14th): 5 hours at rates named in Columns 1 and 3.

◆ NOTE 2 - When pianos are part of a move, the following charges will apply in addition to the hourly rates shown above:

NOTE 3 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

▲ NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in columns 2 or 3 when distance from original point of origin to final destination is 20 miles or less.

A flat charge based on one and one half hours at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is more than 20 miles but not exceeding 30 miles.

A flat charge based on two hours at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is more than 30 miles but not to exceed 40 miles.
