Attached are updates for 468<sup>th</sup> Revised Page 2, 236<sup>th</sup> Revised Page 2-A, 103<sup>rd</sup> Revised Page 6, 4<sup>th</sup> Revised Page 63-E, 2<sup>nd</sup> Revised Page 63-E-1, 1<sup>st</sup> Revised Page 63-E-2, and Original Page 63-E-3 for L&J Transportation Companies, Inc. (PA PUC Certificate #A-00109787) in Pottstown PA. This filing is an **INCREASE** in local hourly rates (both Non-Peak Season & Peak Season), a **CHANGE** in the application of packing rate schedule, an **INCREASE** in premiums for Full-Value Protection, a **CHANGE** in the minimum weight charge, and **INCREASE** in labor rates on intrastate moves transported in excess of 40 miles, and the **ADDITION** of a booking commission fee for moves performed for 3<sup>rd</sup> party relocation companies or foreign agents.
