Letter Petition for Leave to Withdraw Complaint

Dear Secretary Chiavetta:

The Bureau of Investigation and Enforcement (“I&E”) of the Pennsylvania Public Utility Commission (“Commission”) files this letter petition for leave to withdraw the Complaint in the above-captioned case pursuant to 52 Pa Code § 5.94.

On November 8, 2019, I&E filed an Amended Complaint alleging that Pocono Cab Company LLC t/a Pocono Cab (“Respondent” or “Pocono Cab”) permitted its driver to operate a vehicle in passenger transportation service while under the influence of a controlled substance in violation of 52 Pa. Code § 29.507. I&E’s Complaint requested that Pocono Cab pay a civil penalty of \$500 or be subject to cancellation of its Certificate of Public Convenience (“Certificate”).

Further investigation revealed that the driver in question is no longer employed by Pocono Cab. Therefore, I&E is withdrawing the Complaint in the above-captioned matter. If no party objects within ten (10) days of service of this letter, this case should be marked closed.
