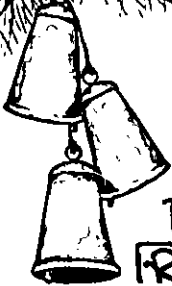

NO WHERE IN MY CORRESPONDENCE WITH THE PUC
DID I SAY OR IMPLY I EXPECTED PERFECT SERVICE ONLY REASONABLE SERVICE.
WHAT I DID SAY IS THAT THE NUMBER OF SERVICE INTERRUPTIONS WAS
EXCESSIVE AND THE FINAL TIME WHEN AN ASH TREE LOAD
FELLEN ON THE POWER LINE CAUSING THAT LINE TO LAY ON THE
GROUND ON MY PROPERTY THEREBY CAUSING A VERY DANGEROUS
SITUATION WHICH COULD HAVE CAUSED SERIOUS INJURY TO
ME OR DEATH TO ANYONE OR ANY ANIMAL THAT CAME
INTO CONTACT WITH THE HIGH TENSION WIRE.

THE COPY OF THE LETTER THAT WAS SENT TO THE PUC AFTER MY INITIAL
CONTACT SAID THAT PENNEL HAD PAID \$75,000 TO REMOVE
423 TREES AND 1071 TREES WERE TRIMMED AND THE CIRCUIT
WAS DUE FOR MAINTNANCE IN 2024.

MY ARGUMENT IS THIS: THE EMERALD ASH BORER IS KILLING
ASH TREES, THIS IS A TRUE FACT. PROPER MAINTNANCE BY
PENNEL REQUIRES THEM TO REMOVE ALL ASH TREES OR
ANY VEGETATION THAT WILL INTERFERE WITH ELECTRICAL
SERVICE. THIS THEIR CUSTOMERS HAVE A RIGHT TO EXPECT.
TO DO LESS IS INADEQUATE, IRRESPONSIBLE AND
NEGLECT.

ALSO, AS CONSUMERS WE HAVE A RIGHT TO RELIABLE,
SAFE ELECTRICAL SERVICE WITHOUT EXCUSES,
FOR WE I HAVE A RESPONSIBILITY TO PAY ALL
LEGITIMATE INVOICES FOR THAT SERVICE WHICH I
AND MY FAMILY HAVE DONE AT THE ABOVE ADDRESS
FOR OUR 50 CONSECUTIVE YEARS ON TIME EVERY
TIME WITHOUT ANY EXCUSES.

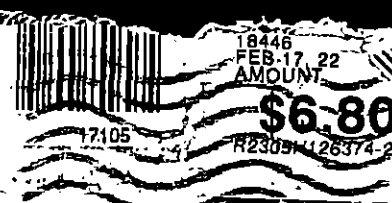
