RULES & REGULATIONS

1. Advance reservations are required and must be made two (2) hours prior to service being rendered.
2. Rates for mileage are determined by the odometer of the vehicle in use and begin when the vehicle leaves (Home Base) 2102 Hoffnagle Street #1, Philadelphia, PA 19152. The final mileage reading is determined upon returning to (Home Base) 2102 Hoffnagle Street #1, Philadelphia, PA 19152.
3. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
4. If any trip requires the vehicle and driver to remain at a destination overnight, or at any point route to a destination overnight, the patron will be responsible for providing carrier's driver with accommodations at an overnight facility (motel, hotel) being utilized by the patron, and all meals required by the carrier's driver. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
5. **CONTRACT SERVICES**
Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

SCHEDULE OF RATES
(Two or Less People)

Flat Rates: \$35.00 for loaded miles from points of pick up to points of drop off, one way, ten (10) miles or less, before any additional dead mile charges may apply.

Mileage Rate: \$2.50 per mile, or any fraction thereof, applies in addition to the Flat Rate stated on all loaded miles, after the first ten (10) miles, from the point of pick-up to the final destination.

Dead Mileage Rate: \$2.00 per mile, or any fraction thereof, before pick up after ten (10) miles, going to pick up destination. Mileage rate and distance for dead miles begin and end at (Home Base) 2102 Hoffnagle Street #1, Philadelphia, PA 19152.

Dead Mileage Rate: \$2.00 per mile, or any fraction thereof, after drop off after ten (10) miles, going from drop off destination. Mileage rate and distance for dead miles begin and end at (Home Base) 2102 Hoffnagle Street #1, Philadelphia, PA 19152.

Waiting Time During Trip: If the driver is requested to wait for a customer at the destination or during a trip, there will be an additional waiting time charge of \$5.00 for every fifteen (15) minute increment, or any fraction thereof.

Additional Passengers Over Two: The additional charge for any extra person or attendant is \$25.00 per trip.
