RE: Investigation into Conservation Service Provider and Other Third Party Access to Electric Distribution Company Customer Data
Petition for an Extension of Time to File Comments Until May 5, 2022

On February 8, 2022, the Pennsylvania Public Utility Commission (Commission) issued a Secretarial Letter at the above referenced Docket No. (Secretarial Letter). The Secretarial Letter sought responses to directed questions and established a forty-five (45) day response period that began upon publication of the Secretarial Letter in the *Pennsylvania Bulletin* (Pa.B.). The Secretarial Letter was published in the February 19, 2022 Pa.B., making the deadline for comments April 5, 2022.

On March 14, 2022, the Energy Association of Pennsylvania (EAP) filed a Petition for an Expedited Order Granting an Extension of Time to File Comments (petition). In its petition, the EAP requests that the Commission extend the response deadline by thirty (30) days, or until May 5, 2022. The EAP states that the Secretarial Letter includes five (5) topic areas comprising thirty-six (36) distinct questions, as well as the opportunity for commenters to raise additional questions or concerns. The EAP further states that the complex questions outlined will require both practical and legal consideration by commenters. As of the date of this letter, no objections to the petition have been filed.

The Commission finds the EAP's reasoning for the extension request compelling and hereby grants its petition. We shall therefore extend the deadline for responses to the directed questions in the Secretarial Letter until May 5, 2022.
