Enclosed for filing with the Pennsylvania Public Utility Commission ("PUC" or "Commission") pursuant to Chapter 21 of the Public Utility Code is the original updated Schedule B-1 of Contract for Services between Citizens’ Electric Company of Lewisburg, PA ("Citizens" or "Company") and its parent corporation, C&T Enterprises, Inc.
