

NOTE 2 - Minimum Transportation Charge: Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Other than Sundays and Holidays (5:01PM to 7:00AM): 4 hours at rates named in Columns 1 and 4.

NOTE 3 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3 and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final the destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.
