

NOTE 5 - In lieu of rates shown in Freight Pa. P.U.C. Nos. 50-T and 51-W, the following shall apply for declared value protection:

For the minimum declared value of the shipment, multiply the actual weight (or, in the case of an hourly move, the estimated weight) times \$2.25 (i.e. 5000 pounds times \$2.25 equals \$11,250.00 declared value). Cost for declared value protection is \$.30 per \$100.00 declared value (i.e. \$11,250.00 declared value times \$.30 per \$100.00 declared value equals \$33.75).

▲ The following fees apply in lieu of rates shown in Freight Pa. P.U.C. Nos. 50-T and 51-W for shipments transported forty (40) miles & less and shipments transported in excess of forty (40) miles and are in addition to all other applicable charges.

▲ NOTE 6 - When a flat screen TV is included in the shipment, an additional handling fee per TV will apply as follows:

32" to 49" TV - \$35.00

50" & larger TV - \$45.00

▲ NOTE 7 - When a shipment has a piano, the following handling fees will apply per piano as follows:

Spinnet Piano - \$75.00 Upright Piano - \$95.00 Baby Grand Piano - \$125.00 Grand Piano - \$150.00

▲ NOTE 8 - When a safe or large cabinet is included in a shipment, the following charges will apply per safe or large cabinet:

Safe/Large Cabinet (400-599 pounds) - \$85.00 Safe/Large Cabinet (600-800 pounds) - \$125.00

▲ NOTE 9 - When heavy exercise equipment is included in a shipment, an additional handling fee of \$65.00 per piece of exercise equipment will apply.

▲ NOTE 10 - A handling fee of \$45.00 per clock will apply when a grandfather or grandmother clock is included in a shipment.
