CERTIFICATE OF SATISFACTION OF COMPLAINT**

Verde Energy USA, Inc. (“Verde Energy”) submits this Certificate of Satisfaction pursuant to 52 Pa. Code § 5.24 (b)(1), stating that the Complaint of CLARENCE LEWIS (“Complainant”) against PPL Electric Utilities Corporation (“PPL Electric”), to which Verde Energy was joined as an indispensable party, has been fully satisfied. The Complainant has acknowledged to the Respondents PPL Electric and Verde Energy that Complainant no longer wishes to pursue the Complaint against the Respondents, in accordance with an agreement reached by the parties. The terms of the Agreement include a requirement that the Complainant will make a \$1,000 payment to PPL Electric. Thereafter, beginning with the April 2022 bills, Complainant will pay his regular monthly bill plus 1/60 of the remaining balance, such payments to continue until all arrearages are paid in full. Consequently, the Commission should mark this complaint closed in accordance with 52 Pa. Code § 5.24(c) unless Complainant objects within ten (10) days of this filing.
