**VEOLIA WATER PENNSYLVANIA, INC.; NAME CHANGE; Supplement No. 62 to  
Tariff Water - Pa. PUC No. 7**

Dear Secretary Chiavetta:

On December 2, 2021, the Pennsylvania Public Utility Commission ("Commission") approved the Joint Application for Settlement (filed on October 27, 2021) of Veolia Environnement S.A., Veolia North America, Inc., SUEZ S.A., SUEZ Water Pennsylvania Inc. and SUEZ Water Bethel Inc. for all approvals pursuant to Sections 1102(a)(3), (4), and 1103 of the Pennsylvania Public Utility Code, and as otherwise required under the Pennsylvania Public Utility Code for the change in control of SUEZ Water Pennsylvania Inc. ("SWP") and SUEZ Water Bethel Inc. ("SWB") (A-2021-3026515, A-2021-3026522, and A-2021-3026523) as modified by the Recommended Decision. The Veolia Environnement S.A. ("Veolia") and SUEZ S.A. ("SUEZ") merger was consummated on Tuesday, January 18, 2022.

Further, the Competition and Markets Authority ("CMA") provided antitrust clearance for the transaction in the United Kingdom on March 10, 2022, clearing the way for Veolia and SUEZ to commence the integration of the Veolia North America ("VNA") and the SUEZ North America ("SNA") businesses, which include SWP and SWB. As part of the integration, there will be a rebranding of the SNA businesses to the "Veolia" brand.

On March 28, 2022, the Pennsylvania Department of State, Corporations Bureau, registered the name change of the entity formerly known as SUEZ Water Pennsylvania Inc. to Veolia Water Pennsylvania, Inc. ("VWP"). A copy of the name registration is attached to this letter as **Appendix A**. As a result of the name change and in compliance with 52 Pa. Code § 53.5, enclosed for filing please find Supplement No. 62 to Tariff Water - Pa. PUC No. 7 (attached as **Appendix B**).

This tariff supplement is being filed solely to reflect the new legal name of VWP. No changes to regulations or rates are included in the supplement. Given that the name change had to be first registered with the Pennsylvania Department of State, VWP was not able to provide the customary public notice for a tariff change. Accordingly, VWP respectfully requests a waiver of the regulation at 52 Pa. Code § 53.31 (pertaining to requirement of notice for tariff

changes), as it relates to the instant tariff supplement, and that the tariff supplement be permitted to become effective on ten days' notice.

Please note that notice of the name change will be provided to VWP's customers through a variety of means. A customer letter is being sent in accordance with bill cycles after March 23, 2022, and will continue for an entire billing cycle. A copy of the notice is attached to this letter as **Appendix C**. Additionally, VWP will further notify customers of the name change in May through a second notification via direct mail, bill insert, and website and social media postings.


