Dear Secretary Chiavetta:

Detailed below are the answers to the data request dated March 22, 2022 pertaining to the application of the above carrier:

1. The description of service is consistent with the majority of the applications across the state since eliminating the requirement to prove need. It should read *"To transport, as a common carrier, by motor vehicle, persons in Limousine service, between points in Pennsylvania, excluding service that is under the jurisdiction of the Philadelphia Parking Authority.*

While he will initially only be using one vehicle and will focus his initial marketing to the Philadelphia and surrounding counties he will only take those trips that he is capable of performing and maybe some of those trips are denied or are farmed out to other carriers with the vehicles available to perform the service. This carrier intends to grow his fleet so that it may be unnecessary to either deny or subcontract with other common carriers to provide the necessary vehicles.

2. Initially there will be two drivers to operate the first vehicle. As demand increases the number of drivers and numbers of vehicles will be adjusted.

3. The initial vehicle to be used is a 2018 Cadillac Sedan VIN

Dear Applicant:

On March 15, 2022, the Commission received the Application of **PHILALIMOSERVICE, LLC**. Upon initial review, the Application has been determined to be deficient for the following reason(s):

- 1) **Your description of the proposed service area is incorrect. You stated, “to transport as a common carrier, persons in limousine service between points in the Commonwealth of Pennsylvania.” You need to state where the service is to originate. Please explain.**
- 2) **Question #5 of the Verified Statement of Applicant is not answered regarding the number of drivers you intend to use or hire in your business. Since you are requesting the proposed service area as the “Commonwealth of Pennsylvania”, your answer of “to be determined” is unacceptable. You need to justify your request for the proposed service area to ensure reliable and efficient service to the public. Please answer the question.**
- 3) **Question #6 of the Verified Statement of Applicant is not answered at all. There is no vehicle information. You stated in your answer to Question #4, that you intend to begin service with one vehicle. You also need to explain how one vehicle will serve the needs of the public in the entire Commonwealth of Pennsylvania in a reliable, efficient, and timely manner.**
- 4) **Statement of Financial Interest is unacceptable. The Statement must be dated. A new Statement of Financial Interest must be filed.**

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within ten (10) days of the date of this letter will result in the Application being dismissed; and, the \$350.00 application fee **will not** be refunded. You must then file a new application.


