PGW’s Motion for a Continuance

Pursuant to 52 Pa. Code §1.15(b), the Respondent Philadelphia Gas Works (PGW)) hereby moves that the Commission grant a continuance in this matter of the Call-In Telephonic Hearing scheduled for 10:00 a.m. on Tuesday, April 26, 2022.

In support of its motion, PGW states as follows:

1. On or about February 10, 2022, PGW was served with the Complaint filed in the above captioned matter, a dispute regarding the validity of a payment purportedly made to PGW in satisfaction of the entire account balance on the Complainant's accounts for gas service on two accounts.
2. On February 28, 2022, PGW filed its Answer to the Complaint denying that the Complainant sent a full payment of her account by regular mail and email.
3. By the Commission’s Notice dated March 7, 2022, this matter has been set for an Initial Call-in Telephonic Hearing to be held on April 26, 2022.
4. On April 5, 2022, counsel for PGW informed the Complainant that he had a scheduling conflict and would be out of town; returning to Philadelphia on April 27, 2022.
5. The Complainant has indicated that she does not object to PGW’s request for a continuance of the Initial Call-in Telephonic Hearing to be held on April 26, 2022.
6. On April 5, 2022 the parties also began discussion of the issues of this matter as the Complainant by email expressed interest in discussing settlement.
7. PGW requests a brief continuance in this matter.
8. There is no immediate harm to either party in the continuance of this matter as the parties may refine the issues to be addressed during settlement discussions, if settlement is not reached.

9. PGW has shown that there is just cause for the granting of this request for a continuance of the Initial Call-in Telephonic Hearing to be held on April 26, 2022.

WHEREFORE, PGW requests that the Call-In Telephonic Hearing of this matter scheduled for Tuesday, April 26, 2022 at 10:00 a.m. before Administrative Law Judge Arlene Ashton be continued.
